4. How good is the cash flow?

Excellent. It is an all-cash business. There are no receivables.

5. Once I am in business, how long before I start making money?

One nice thing about this business is that from the first day your machines are on location, your machines will begin to make you money. There is waiting for months or years to build a clientele. Your vending machines are like a silent sales force working for you. They are on the job continually selling 24 hours a day 7 days a week.

6. Do I have to sell?

No. Just put the machines on location, refill, and collect the money. The industry has created a huge demand for name brand candy products and you are taking advantage of that.

7. How much do I pay the business owner where my machine is located?

The business owners allow the machine in their establishment because it is a convenience to their employees and customers. Many machines can be charity sponsored for easy placement. However, in some great locations it is best to split with the business owner 15% to 20% to make sure you have that location a long time.

8. Is the market saturated, and are there enough locations for me to expand?

Although you can see vending machines everywhere, there are between two and three million new small businesses starting each year. This is a very attractive, high quality machine that can easily replace unwanted gross looking machines!

9. Do I need special skills to operate these vending machines?

No. All you need is the desire to manage your own business.

10. Where do I buy my products?

You will be able to conveniently pick up all types of vendible product from Sam's Club, Costco, other local vending product distributors or order your product online.

11. How many pounds of Candy does a machine hold?

The machine holds 9 lbs. of Candy. Approximately 300 Vends.

12. How many machines am I able to have and allowed on a route?

As many as 300 or more. It depends on how much money you wish to make and how much time you are willing to invest. Large routes may include managing other people and maintaining some inventory.

13. How much money can I make?

It all depends on the number of machines and the quality of your locations. The higher traffic locations tend to have more sales.

14. Is the machine easy to assemble?

Yes. It can be assembled in 5 - 10 minutes, and easy-to-understand directions are included with your machine.

15. Do I need a truck or van?

No. Most people service their routes using their existing vehicle.

16. Where are the vending machines placed?

Because of their attractive designs, the machines can be placed in almost any restaurant, business or office location. There is a list of possible locations in this business success kit. We will also give you the contact information for several professional location companies, if you desire.

17. Are special marketing techniques needed?

It is good to give out samples to those in the location to get them familiar with the great tasting products you are providing. Generally, people have already tried most of your national advertise products and you should be able to just place the machines in the locations you have approved, refill the machines, and collect your profits.

18. How long does it take to get started?

We can usually have your machines to you within 7-21 days from the day we receive your funds for your order.

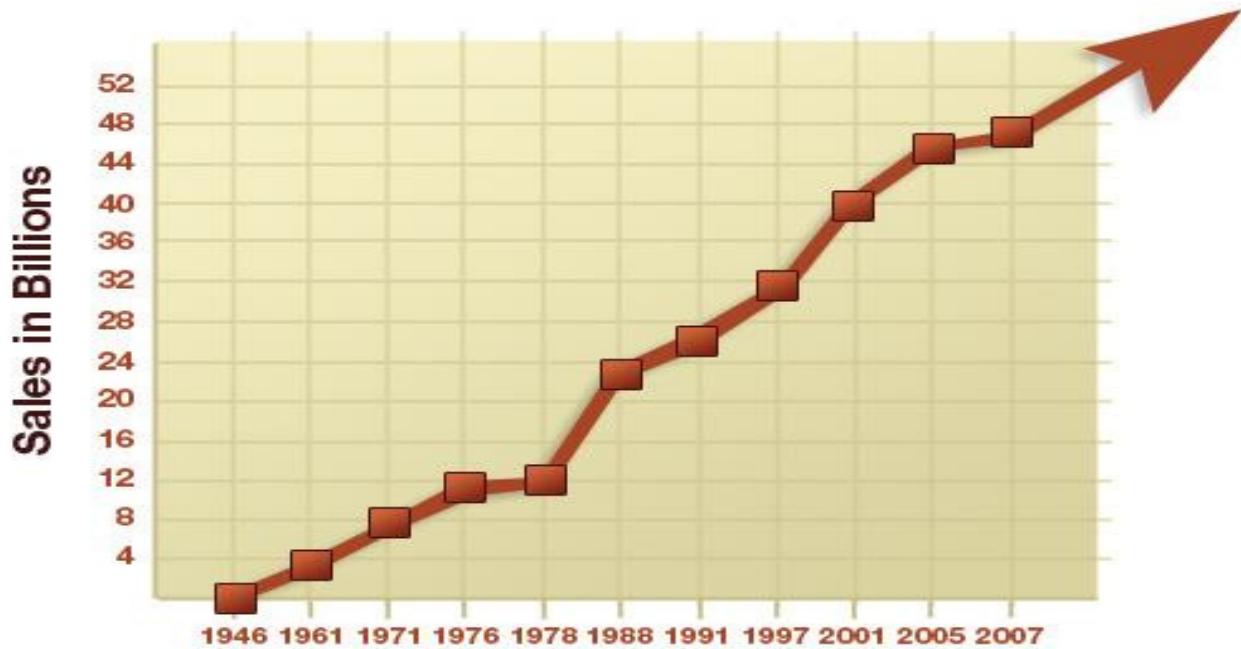
19. How much can I earn with 30 King Karousel Vending Machines?

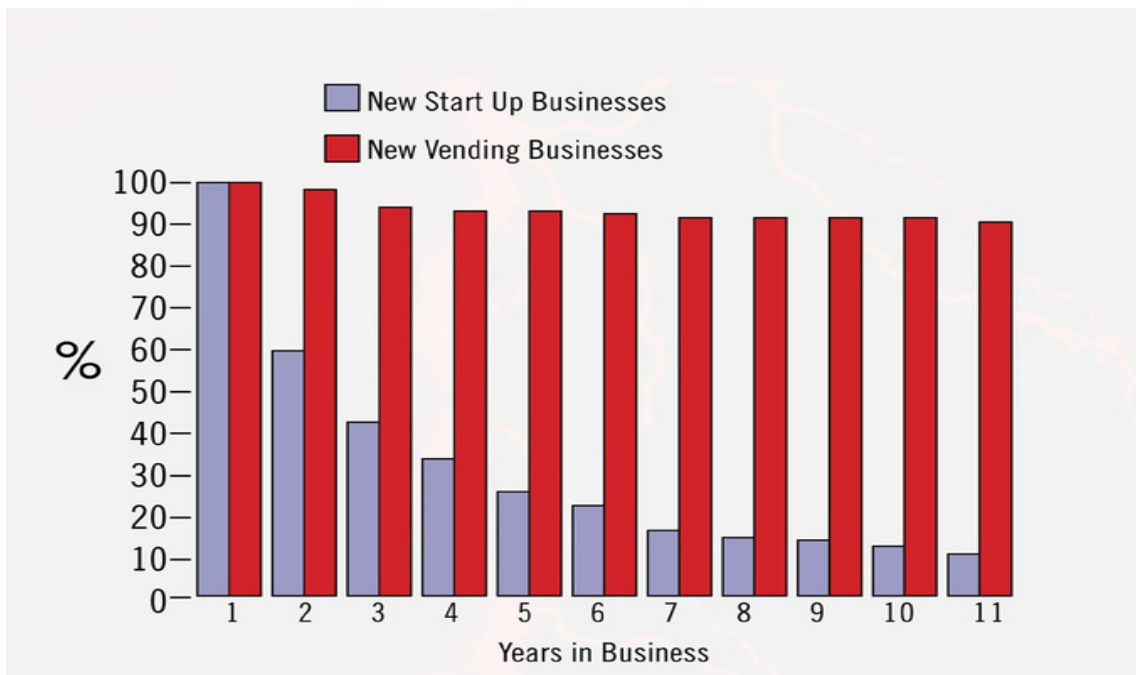
20. Do you provide locations?

Terms & Conditions

Vend Routes (the "Seller") agrees to sell and the Buyer agrees to buy the product described on the reverse side at the price described on the following terms and conditions.

1. The Seller agrees to ship the product within thirty (30) days from receipt of this Purchase Order Agreement accompanied by full payment. Delivery shall be subject to and contingent upon strikes, labor difficulties, fire, storm delay or defaults of common carriers, failure or curtailment in Seller's usual source of supply, government decrees or orders, or any other delays beyond the Seller's reasonable control, and the Seller shall not be liable for any loss or damage arising therefrom. If delivery is not made within forty-five (45) days of receipt of the Purchase Order Agreement and cleared funds from the Buyer, Buyer may notify Seller in writing and cancel the Purchase Order Agreement. If Seller can't fulfill the order the purchase price will be refunded in full. Title to the product and/or goods shall not pass to the Buyer until total due is paid in full. Product and/or goods purchased are for a business purpose. Delivery and location of product is Buyer's responsibility, and all products and/or goods are freight prepaid.

2. The manufacturer guarantees to replace any vending equipment which is found to be defective in material or workmanship within thirty (30) days from the date of purchase. The obligation with respect to such vending equipment shall be limited to replacement F.O.B., Manufacturer, and in no event shall the Seller be liable for consequential or special damages, or for transportation in connection with such equipment or parts. **THIS WARRANTY IS EXPRESSLY MADE IN LIEU OF ALL OTHER WARRANTIES EXPRESSED OR IMPLIED, INCLUDING THE WARRANTIES OF MERCHANTABILITY AND FITNESS.**

3. This Purchase Order Agreement is intended by the parties as a complete and final expression of the entire Purchase Agreement between the parties and as a complete and exclusive statement of its terms. Both the front and back of the Agreement have been read and agreed to by Buyer and Buyer hereby acknowledges he/she has done so with a clear understanding of this Agreement and all of its terms and provisions. Buyer has been given the opportunity to have an attorney and/or financial advisor review this document. Buyer understands and agrees that Seller offers no buy-backs, money back guarantees, or refunds. Buyer agrees that he/she is not relying upon any verbal or written representation whatsoever, except as expressly set forth in this Agreement. Buyer acknowledges and agrees that Seller does not guarantee or represent any minimum earnings as earnings are rendered by the Buyer, all of which factors are beyond the control of the Seller. This Agreement can only be modified in writing, signed by the parties, or their duly authorized agents. Deposits are none refundable. Seller reserves the right to modify and upgrade changes in packaging and product content of the product line.

4. Buyer and Seller expressly agree that the laws of the State of Utah shall govern the validity, construction, interpretation and effect of this Agreement. In any dispute arising from or related to this Agreement, Buyer and Seller mutually consent to jurisdiction and venue in any state or federal court located in the County of Sheridan, State of Wyoming. Should Buyer initiate proceedings not in accordance with this provision, Buyer shall be responsible for all attorneys' fees and expenses incurred by Seller in obtaining a dismissal or stay of that lawsuit by the court.

5. Seller will provide Buyer with items as herein provided for at the specified price. Seller shall ship F.O.B. warehouse to the Buyer's address as stated herein. In addition, Seller will give Buyer an opportunity to purchase additional products upon request by Buyer.

6. Seller agrees to appoint and maintain during the term of this Agreement an agent for the receipt of service of process within the State of Wyoming with respect to any action arising out of or based upon the relationship between the Seller and Buyer. The seller's agent for service of process in the State of Wyoming is Robert Newmark, 30 North Gould Street Suite R Sheridan Wyoming 82801. Seller reserves the right to change its agent for service at any time and will provide written notice to Buyer if such an event occurs.

7. Seller does not warrant or represent that any profits may or will be generated from the purchase as set forth on the reverse of this Agreement. This is a continuing agreement. There is a degree of risk involved in owning vending machine equipment, in that individuals may generate little or no income from the vending machines for various reasons, including the lack of business acumen and experience in the industry.

8. Buyer shall be responsible for all Federal, State and Local taxes as well as all licenses required to do business and shall act as an independent entity in all matters concerning Buyer's business.

9. Buyer hereby acknowledges that all purchases are non-refundable. All training material is delivered at the point of purchase.

10. Buyer agrees and understands that any and all locations are the sole responsibility of the Buyer and not the Seller and it is the Buyer's sole responsibility to independently locate the units. Buyer agrees and understands that the Seller will not provide locating service information unless available and requested by Buyer and that any decision by Buyer to hire a locating company is the Buyer's sole responsibility. Seller has not responsibility in locating the equipment.
